Our Goal







Why is Consent Education Critical?

The prevalence of violence and sexualized violence remains pervasive in society.

What we are currently doing is not working.

- Sexualized violence and intimate partner violence is increasing across the country
- Police reported level 1 sexual assaults increased 19% from 2020 to 2021; among intimate partners, reported level 1 sexual assaults increased 22% from 2020 to 2021.
- 2021 was the seventh year in a row that police reported intimate partner violence incidents increased in Canada 79% of survivors were women and girls, at a rate nearly four times that of men and boys

Why is Consent Education Critical?

The Big Picture - We know that protective factors may lessen the likelihood of sexual violence victimization or perpetration. These factors can exist at individual, relational, community, and societal levels.

- Families where caregivers work through conflicts peacefully
- Emotional health and connectedness
- Academic achievement
- Empathy and concern for how one's actions affect other





Why the Consent Café Works

- We meet participants "where they are at", where they learn, and where they are navigating consent every day.
- · We are current in our content
- We are reflexive our curriculum is youth informed
- Consent Café Mentors help create a bridge between the curriculum and the real-life application of the content




Role of Consent Café Mentors

- Establish and support respectful and courageous learning environments
- Model styles of participation and engagement
- Co-regulate
- Support comprehension and application of material
- Listen and observe within their small groups
- Provide immediacy and responsiveness
- Make Consent Cafés fun!

Consent Café Curriculum Lesson 1: Relationship, Emotional Regulation, and Resources

Learning objective: Participants will prepare for a responsive and supportive learning environment


- <u>Take away:</u> Think about desired consent learning, grounding item
- <u>Learning outcome:</u> Participants will build connections, learn grounding strategies, and establish an understanding of the Consent Café



Consent Café Curriculum Lesson 2: Consent and Communication

Learning objective: Participants will develop a fulsome understanding of consent and the communication skills integral to accurately navigating consent

- Take away: Talk to parents/caregivers about how consent exists within the home
- Learning outcome: Participants will develop a fulsome understanding of consent and how it applies to all aspects of their lives



Consent Café Curriculum Lesson 3: Online Consent and Online Safety

Learning objective: Participants will develop an understanding of online consent, ways to engage online safely, and that adult supports are required if harm is present. In addition, empathy and compassion for victims/survivors of sextortion and sexploitation is emphasized.


- <u>Take away</u>: Identify an adult to report to if experiencing extortion, exploitation, or other online or in-person harms
- <u>Learning outcome</u>: Participants will understand their online vulnerabilities, be able to identify a helpful adult, and the steps required to report harm




Consent Café Curriculum Lesson 4: Relationships, Violence Prevention and Communication

Learning objective: Participants will develop an understanding of relationships across a spectrum of healthy to abusive

- Take away: Identify an adult to report to if experiencing violence, violence is never the fault of the victim/survivor
- Learning outcome: Participants will be able to identify healthy, unhealthy, and abusive relationship communication patterns, and be able to identify a helpful adult if needed

Talking to Your Teens about Consent

- Listen
- Believe
- Empower

If you want your teen to disclose any type of online/inperson harm with you, working to build a safe, trusting relationship is the key

Work on building your own grounding strategies, so you have ways to calm and ground yourself in case they share hard to hear information with you

Openly talk about and model consent (i.e., don't force them to hug people they don't want, share with them how you are starting to use consent with people in your life)

Work to stay calm if they tell you about a mistake they made. If you feel activated, you can use a grounding strategy - because you have been practicing;)

Consent Café Journal

- Developed to increase and enhance student engagement
- Developed to increase and enhance students' comprehension and understanding of the Consent Café Curriculum and to encourage self-reflection and critical thinking
- Developed to share local and online resources

Sample of Participant Feedback

What was your favourite part of the Consent Café?

- "The nice mentors and the colouring and fidgets."
- "Probably the conversations...from the questions being asked [about] situations from [real] life."
- "Getting to talk about our experiences and having that comfort feeling."
- "The relationships."
- "Communication and how welcoming the people are."
- "I enjoyed learning how much consent effects our everyday lives."
- "It was inclusive, as well as didn't feel awkward and I looked forward to it. The 'lessons' were well spoken."
- "The fun games like kahoots and bingos with the prizes and the daily question how we were feeling."
- "My favourite part was the activities because it taught us while having fun."

How can we improve the Consent Café?

- "Maybe go into more relationship stuff."
- "More snacks."
- "IDK."
- "Hot chocolate."
- "More activities."
- "Go more in-depth on friendships and have more boundary setting and consent practices."
- "More fidgets."
- "More talk about sex."
- "More physical activity."
- "Maybe make it a longer experience."

Sample of Participant Feedback

Do you have any additional feedback?

- "I could have used this info when I was younger. I think this should be in all high schools."
- "It was really fun and [I] learned information that I didn't realize fit under the context of consent".
- "No, you guys are a perfect group ""
- "More snacks!!!"
- "I am very happy you were able to come to our school."
- "I appreciate that this was well thought out and student's opinions were taken into consideration."
- "I think I learned a lot about this and I understand it more."

The Consent Café Empowers Youth

"I attended the Consent Café this spring. I feel like if we were all taught at a young age what consent is some situations could be prevented. I already had a general knowledge of consent, but I learned more about physical and sexual online consent at the Café. I had a little understanding of physical consent, but I didn't know how to use it, so the Consent Café was definitely an eye opener on how to use my consent properly. I never talked about sexual consent before, so it was hard to learn about, but I also didn't know how to say no without hurting feelings, so at the Consent Café I learned how to speak up for myself more. I felt safe and calm surrounded by comfort, and I like how they were really open, and they didn't like sugar-coat anything or hide anything, so it was just like a really empowering."
